AUTHORIZATION FOR THE USE OF MINORS' IMAGES

(RGPD 2016/679 and LOPDGDD)

CLAUSES

FIRST.- CONSENT

By this document, I give my express and unequivocal consent for the center, identified as Escuela Infantil Pequeños Genios, to capture and use images of my child, Lucía Pérez González, in the activities organized by it, in accordance with the provisions of Article 6.1.a of Regulation (EU) 2016/679 (RGPD). This consent is given freely and voluntarily, after having been duly informed about the purpose of the image processing, which is the promotion of the center's activities and the dissemination of events on the authorized platforms: sitio web de la escuela, redes sociales.

SECOND.- SCOPE OF AUTHORIZATION

This authorization allows the capture, reproduction, and dissemination of the minor's images in the following media: a) Institutional social networks of the center, such as Facebook, Instagram, and YouTube. b) The official website of the center. c) Printed materials such as newsletters and promotional brochures. The images will be used exclusively for the educational and promotional purposes indicated, without allowing their use for commercial or lucrative purposes.

THIRD.- DURATION OF AUTHORIZATION

The granted authorization will be valid for the current school year, counted from the date of signing this document. After this period, the images will be deleted from the center's digital platforms and physical files, unless the consent is expressly renewed. The signatory may revoke this authorization at any time, without affecting the lawfulness of the processing based on the consent prior to its

withdrawal, in accordance with Article 7.3 of the RGPD.

FOURTH.- RIGHT OF REVOCATION

The signatory has the right to revoke the consent given at any time, by written notification addressed to the data controller at the address Calle de la Paz, 45, 1º, 28012 Madrid. The revocation will take effect from the date of receipt of the notification and will not affect the processing carried out previously. The center undertakes to cease the use of the minor's images and to proceed with their deletion from the platforms where they are published.

FIFTH.- SECURITY MEASURES

The center, as the data controller, undertakes to implement appropriate technical and organizational security measures to ensure the protection of the minor's personal data, in accordance with Article 32 of the RGPD. These measures include, among others, access control to the images, encryption of digital files, and staff training in data protection.

SIXTH.- PROTECTION OF PERSONAL DATA

In accordance with Article 13 of the RGPD and the LOPDGDD, the signatory is informed that the personal data provided will be processed by Escuela Infantil Pequeños Genios for the purpose of managing the authorization for the use of the minor's images. The signatory may exercise their rights of access, rectification, erasure, restriction of processing, portability, and objection by contacting the address Calle de la Paz, 45, 1º, 28012 Madrid. They also have the right to file a complaint with the Spanish Data Protection Agency if they believe their rights have been violated.

SEVENTH.- APPLICABLE LAW AND JURISDICTION

This document is governed by Spanish law, particularly by Regulation (EU) 2016/679 (RGPD) and Organic Law 3/2018, on the Protection of Personal Data and guarantee of digital rights (LOPDGDD). For any dispute that may arise from the interpretation or execution of this document, the parties submit to the jurisdiction of the Courts and Tribunals of Barcelona.
